
2. General


- 2.1. **Voting in new members** The following members were voted by a show of hands:
 - Meagan Foss (Meade Rep)
 - Toni Tolpo (Echo Rep)
 - Sara Burns (Echo Rep)
 - Kyriakos Ioannou (IT and Technical)
- 2.2. **Member recruitment** update: latest number versus target of 1700 (Diane/Neil)
 - 2.2.1. Currently 518 subscribers approx half resident tenants, half leaseholders.
 - 2.2.2. May include double counting.
 - 2.2.3. Crowdsignal(paid survey tool) gained us approx. 58 new members (20% leaseholders)
- 2.3. Matters arising from **monthly meetings with Ballymore** -Dan Cross & Justin Kent see minutes for detail and progress
 - 2.3.1. Consultation on community centre note 2.3
 - 2.3.2. YuaHaw to lead the group to have our views communicated to Ballymore
 - Diane to ask for a tour.
 - We can use Crowdsignal to get views
- 2.4. **Diversity & Inclusion** note that RA constitution is inclusive
 - 2.4.1. Simon Todde (guest) complained that he felt *discriminated* against. He complained that the RA had requested this. Mel Henson said that it had never been part of an RA meeting, all meetings are minuted and fully transparent, and Simon had never been discussed at all. He then clarified that it was *an individual RA member* who had made the complaint. Simon recounted an incident that had been asked by security not to hold his classes, but other people who are white had not. Simon said he felt that people should be treated fairly and equally. He also asked that the management should not use the RA as back up(?) when it has not been discussed in meetings. It was agreed that the RA will raise this with the management team and request them not to do it anymore.

- 2.4.2. Anamaria said it's important to open an honest and sincere dialogue, and suggested a "monthly dialogue", which she will lead. This group will talk about their experiences on the island and how to improve this. (Wouldn't that be part of the "Living Experience" Sub-committee? Section 4 of minutes)
- 2.4.3. Neil suggested that the *Asian community*, which makes up a sizable number of residents, should also be included in this "monthly dialogue".
- 2.4.4. Judith Watson-Bruhne supported *Bias training*, as she gets this from her workplace and finds it invaluable.
- 2.4.5. Diane will ask *Ballymore to participate* in this "monthly dialogue" meeting.

2.5. Consideration of LCILRA approach to resident micro-businesses

- 2.5.1. Anamaria complained about the email sent out by Ballymore (From: London City Island < fitnessmanager@londoncityisland.net > Subject: London City Island & Goodluck Hope Health Club Update Date: September 21, 2020)
- 2.5.2. Emily pointed out that this was from Ballymore, not LCILRA.
- 2.5.3. Diane said we had asked for clarity. We thought it was going to be given to us(*Why?*) but it was sent out to all.
- 2.5.4. Nick pointed out that Ballymore did not say such microbusinesses were banned, just that they had to apply for a licence.
- 2.5.5. Emily asked Simon to try to work with Ballymore to find a way to move forward.
- 2.5.6. A vote was held, and a majority agreed that the LCILRA should give promotional support to microbusinesses (defined as a business that does not pay to use LCI/GLH facilities or land. The vote was held twice as the wording in the first vote was felt by some to be confusing, but the result was the same. (see the 2 screenshots of poll results below).
- 2.5.7. The action agreed was that we will get more clarity from Ballymore about how microbusinesses can be *licensed and pay* to use the land and facilities.





- 2.6. Right to manage group
 - 2.6.1. Diane said that she had reached out to Aswin's group offering to help educate residents but had received no reply. This matter is now considered closed.
- 2.7. Using **the paid survey tool** "Crowdsignal" for subcommittee issues e.g. outdoor/indoor gym equipment, social events suggestions /enthusiasm, community centre ideas. Neil said he'd be very pleased to work with anyone from subcommittees.
- 2.8. Application of the constitution with regard to **non-attending committee members:** It was noted that committee members who do not attend two meetings and send no apologies cannot remain part of the committee.

3. Finance update (Emily)

- 3.1. Accounts movement & bank balance
- 3.2. Bank details changeover
- 3.3. Fundraising, grants
 - 3.3.1. Emily said that there was £150 in the funds, and £80 has been committed to the Crowdsignal so future meetings to address fundraising to fill this shortfall again.
 - 3.3.2. Emily asked for future meetings to consider how the money is given out to sub-committees rather than a 'first come first served' approach.

4. Sub-committee reports

4.1. Service charges (Nick)

- 4.1.1. Update on accounts delivery to the LRA
 - Now that 2018 has been issued, Nick has met with Ballymore who requested a scope of work and letter of engagement. We are just waiting for final sign off for this to go ahead. It was recognized that this is a huge achievement, and Nick was congratulated for his hard work.
 - Nick has a Section 20b notice which is normally issued in the case of accounts not issued within correct time period. The notice has been sent because the delay of 2019 accounts.
 Nick confirms the 2019 Accounts have shown a surplus against budget but that will not necessarily translate into money for individuals. Nick to do more analysis.

- Nick said that the 2019 accounts will probably be available by end Nov and his next priority is to chase that.
- He now has regular meetings with Sally Ann James and Dan of Ballymore. It's slow progress but an improvement on where we were.
- Nick said that the main help he'd like is analysis, and also responding to residents' queries.
- Nick said that it's generally true that the first 5 years of a residential development are the most uncertain because it's difficult to know what costs are coming through, but now there should be more consistency.
- 4.1.2. Service charge review consultant: Nick has spoken to Graham Pack, independent consultant to provide analysis and recommendations and make sure things are fair and correct and that things that should be allocated e.g. construction were not in there.
- 4.1.3. Combined LCI / GLH budget

4.2. Property issues (Arek)

- 4.2.1. Cooker hoods feedback on Ballymore response to a letter by a residents' cooker hood action group. According to Ballymore the cooker hoods have been designed in line with regulations. Ballymore has promised to escalate it and will improve it if it can be improved. We are now waiting. The Pressure Group Islanders Forum have said that they are now going to refer to the Ombudsman. If there are any issues, photos should be provided.
- 4.2.2. Lighting in building corridors (request by Lucia Gasparre). Arek had posted on FB. He said when lights don't light up it's normally because of a faulty sensor. If a photo can be provided, and details of the floor and the building, Arek can take it to Ballymore.
- 4.2.3. Diane said we can use the survey tool. We don't handle issues that affect just one person, but the survey would show if it was issues affecting a lot of people.
- 4.2.4. Arek said we should try to deal with one issue at a time to try and get more focus and action.
- 4.2.5. Lifts Vandalism. Arek asked if fake CCTV could be put in. Also asked for a cost for a real cctv. Ballymore said that it was looking into ways to removing it.
- 4.2.6. Balcony cleaning some advice from Ballymore on cleaning.
- **4.3. SW Energy (Kyriakos Iaonnou)** Kyriakos said some people had a meeting with some people and got together. There is not much to update but it will be at the next meeting.

4.4. Area development (Jules & Arek)

- 4.4.1. Update on meeting with Orchard Wharf
- 4.4.2. Other new developments close to LCI/GLH
- 4.4.3. Engagement with Tower Hamlets on planning policy

- 4.4.4. Engaging a planning consultant (incl Ballymore offer) re Orchard Place development
- 4.4.5. Engagement with local politicians planning for visit
 - Jules and Arek met with Simon Harrington of Regal Homes, developers of Orchard Wharf on Monday Sep 14:
 - Jules showed a draft plan.
 - Vehicles will enter the development and work inside it, they won't be parked on the street although there is still concern about the traffic going past the D3 bus stop.
 - Plan is going in this October this is when we can make comments on it. Arek and Jules will make people aware at the time. There's not much we can do between now and then.
 - One of the encouraging things is that the preference is to have a smaller fleet of vehicles. They have to deliver a working wharf because it's safeguarded. The fact that it is also residential means they are keen to keep the industrial to a minimum.
 - The crane and barge solution proposed limits usage as only 4 boats a day could come in per day because of high tide. Equivalent to 8 HGVs per hour. An alternative such as a jetty would have higher.
 - They have employed Space Hub to do the landscaping same firm who have done the landscaping at GLH.
 - Meeting up with a consultant Jules said that if objections are sent to
 the council and are to be effective, they need to be framed in relation
 to a violation of a particular planning policy. This information is hard
 to obtain without expert help as there are so many lengthy and
 complex planning policy documents. This information could be
 provided by the consultant who Ballymore have offered to introduce
 us to.
 - The meeting felt that in this instance, Ballymore and residents' views are aligned. Jules will arrange to meet with the consultant to find out what they can offer e.g. helping to flag non-compliance.

4.5. Social events (Neil)

- 4.5.1. The social committee is very active and meets regularly.
- 4.5.2. Coming up we need to be mindful of the new rules, **the Rule of 6**. At next meeting he will discuss what can be done.
- 4.5.3. It's important we don't organize events that are seen to go against the said Rule.
- 4.5.4. Neil said the takeaway barbecue was a great success. He said he was keen for ideas for how we can make things work.

4.6. Sports & Fitness (Dan D)

- 4.6.1. Gym issues the *app* not allowing LCI bookings, closures, cleaning, enforcement of distancing & sanitizing
- 4.6.2. Consultation on gym equipment and sports track markings

- 4.6.3. Dan said that we are pushing for *clear guidelines* on what can and can't be done in the green space. We also want clear guidelines on what we can and can't do on booking things.
- 4.6.4. There has been so much *closure of the gym* Should we expect a reduction in service charge because of that. Ales said he had had six people complain about *service charge*.
- 4.6.5. Emily pointed out that all businesses are struggling with the new rules of running a facility in this time of Covid, and may be doing the best they can with the constantly changing situation.
- 4.6.6. **General service** needs to be improved. Dan said that the GLH gym seems to have made the situation worse because staff have to run from one to another. Ales said we have one resource and we can't use it as much as we can. Cleaning is not being done. There is now one session 11-12 then 1.30(???)
- 4.6.7. Dan's final point was *lack of impact*. For example, Gym Equipment: We were told we would enter into good faith discussions that residents could have input on gym equipment but healthclub bought equipment without taking residents' wishes into account. They should have spoken to us before they buy it. It was agreed to escalate this. Ballymore should consult and not 'DO' to the residents. On a positive note, we can do a survey for Steel Warriors outdoor equipment (made from amnesty knives) to see if residents want it. Steel Warriors are very keen to work with us.
